9.	Were you ever told by any owner or tenant of the land crossed by the way, or by anyone in their employment, that the way was not public? If so, state when and give particulars and dates.	
10.	Have you ever known any locked gates or other obstruction to the way? If so, state when and give particulars.	
11.	Have you ever seen notices such as "Private", "No Road", "No Thoroughfare" or "Trespassers will be Prosecuted", on or near the way? If so, when and what did the notices say?	
12.	Have you ever been given permission to use the way?	
13.	Can you give any further particulars?
